


# **PMI** Report on China Manufacturing

## China's manufacturing PMI drops to 49.2 in April, indicating a slowdown in the manufacturing sector

All of the 13 sub-indices were lower than their respective levels in the previous month. For example, the new orders index fell by 4.8 pts to 48.8 in April, indicating a contraction in market demand. The new export orders index also declined by 2.8 pts to 47.6 in the month, returning to the contractionary territory after a two-month expansion. Against this backdrop, the growth in production activities has slowed sharply: The output index slid 4.4 pts to 50.2 in April. Also noteworthy is that the input prices index dropped by 4.5 pts to 46.4 in April, returning to the contractionary territory for the first time since August last year. Meanwhile, the ex-factory prices index went down by 3.7 pts to 44.9 in the month.

By size of enterprises, the PMI of 'large enterprises' declined to 49.3 in April from 53.6 in March. The PMI of 'medium enterprises' went down to 49.2 in April from 50.3 in March. The PMI of 'small enterprises' fell to 49.0 in April from 50.4 in March.

The output index fell to 50.2 in April from 54.6 in March. The output indices of 'large enterprises' and 'small enterprises' remained above the neutral level of 50, registering 50.1 and 50.7 respectively in April. Meanwhile, the output index of 'medium enterprises' dropped below 50, registering 49.8 in the month.

The new orders index slumped to 48.8 in April from 53.6 in March. The new orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all dipped into the contractionary zone, registering 49.0, 49.3 and 47.6 respectively in April.

The new export orders index decreased to 47.6 in April from 50.4 in March. The new export orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were all below the critical 50-mark, registering 47.7, 47.8 and 46.9 respectively in April.

The backlogs of orders index went down to 46.8 in April from 48.9 in March. The backlogs of orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were all below the neutral level of 50, registering 47.6, 45.9 and 46.4 in April.

The stocks of finished goods index edged down to 49.4 in April from 49.5 in March. The stocks of finished goods index of 'large enterprises' came in at 50 in April. Meanwhile, the stocks of finished goods indices of 'medium enterprises' and 'small enterprises' stayed in the contractionary zone, registering 48.1 and 49.8 respectively in the month.

The stocks of major inputs index fell to 47.9 in April from 48.3 in March. The stocks of major inputs indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 47.8, 47.7 and 48.4 respectively in April.

The purchases of inputs index came in at 49.1 in April, down from 53.5 in March. The purchases of inputs indices of 'large enterprises' and 'medium enterprises' were in the contractionary zone, registering 49.1 and 48.2 respectively in April. Meanwhile, the purchases of inputs index of 'small enterprises' rose above 50, registering 50.2 in the month.

The imports index decreased to 48.9 in April from 50.9 in March. The imports indices of 'large enterprises' and 'medium enterprises' remained below the neutral level of 50, registering 48.9 and 48.0 respectively in April. Meanwhile, the imports index of 'small enterprises' moved above 50, registering 51.4 in the month.

The input prices index plunged to 46.4 in April from 50.9 in March. The input prices indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were all below the critical 50-mark, registering 45.8, 46.4 and 47.9 in April.

The ex-factory prices index came in at 44.9 in April, down from 48.6 in March.<sup>1</sup> The exfactory prices indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were all below the neutral level of 50, registering 44.4, 45.5 and 45.2 respectively in April.

The employment index went down to 48.8 in April from 49.7 in March. The employment indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all stayed in the contractionary zone, registering 49.1, 48.5 and 48.5 in April.

The suppliers' delivery time index came in at 50.3 in April, down from 50.8 in March. A reading above 50 implies faster delivery; below 50, slower delivery. The suppliers' delivery time indices of 'large enterprises', 'medium enterprises' and 'small enterprises' registered 50.4, 50.3 and 50.1 respectively in April.

The business expectations index went down to 54.7 in April from 55.5 in March.<sup>2</sup> The business expectations indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were 54.4, 55.4 and 54.5 respectively in April.

## **CFLP**

#### 中國物流與採購聯合會

China Federation of Logistics & Purchasing (CFLP) is the logistics and purchasing industry association approved by the State Council. CFLP's mission is to push forward the development of the logistics industry and the procurement businesses of both government and enterprises, as well as the circulation of factors of production in China. The government authorizes the CFLP to produce industry statistics and set industry standards. CFLP is also China's representative in the Asian-Pacific Logistics Federation (APLF) and the International Federation of Purchasing and Supply Management (IFPSM).

### NBS

#### 國家統計局

The National Bureau of Statistics (NBS), an agency directly under the State Council in China, is in charge of the country's statistics. It is responsible for formulating statistical policies and establishing the national statistical system, drafting and enforcing the statistical laws and regulations, setting up and improving the national economic accounting system, conducting censuses, as well as making statistical analyses and forecasts of the macroeconomy, social development, scientific advancement, resources and environment.

## **China Manufacturing PMI**

#### 中國製造業採購經理指數

China Manufacturing Purchasing Managers' Index (PMI) provides an early indication each month of economic activities in the Chinese manufacturing sector. It is jointly published by China Federation of Logistics & Purchasing (CFLP) and the National Bureau of Statistics (NBS). Fung Business Intelligence is responsible for drafting and disseminating the English PMI report.

Every month questionnaires are sent to 3,000 manufacturing enterprises all over China. The data presented herein is compiled from the enterprises' responses about their purchasing activities and supply situations. CFLP makes no representation regarding the data collection procedures, nor does it disclose any data of individual enterprises. The PMI should be compared to other economic data sources when used in decision-making.

3,000 manufacturing enterprises in 31 industries from Eastern, Northeastern, Central and Western China are surveyed. The sampling of the enterprises involves the use of Probability Proportional to Size Sampling (PPS), which means the selection of enterprises surveyed is largely based on each industry's contribution to GDP, and the representation of each geographical region.

There are 13 sub-indicators in the survey: Output, New Orders, New Export Orders, Backlogs of Orders, Stocks of Finished Goods, Purchases of Inputs, Imports, Input Prices, Stocks of Major Inputs, Ex-factory Prices, Employment, Suppliers' Delivery Time and Business Expectations. An index reading above 50 indicates an overall positive change in a sub-indicator; below 50, an overall negative change.

The PMI is a composite index based on the seasonally adjusted indices for five of the subindicators with varying weights: New Orders—30%; Output—25%; Employment—20%; Suppliers' Delivery Time—15%; and Stocks of Major Inputs—10%. A PMI reading above 50 indicates an overall expansion in the manufacturing sector; below 50, an overall contraction.

Currently there are more than twenty countries and regions conducting the PMI survey and compilation, based on an internationally standardized methodology.
