


PMI Report on China Manufacturing

China’s manufacturing PMI edges up to 49.0 in June, indicating easing downward pressure on the manufacturing sector

Four of the 13 sub-indices were higher than their respective levels in the previous month. For example, the new orders index went up by 0.3 pts to 48.6 in June, pointing to a slower contraction in market demand. The output index rebounded by 0.7 pts to 50.3 in June, returning to the expansionary zone and indicating a recovery in production activities. Besides, the input prices index jumped by 4.2 pts to 45.0 in June, while the ex-factory prices index increased by 2.3 pts to 43.9 in the month. Meanwhile, the purchases of inputs index edged down to 48.9, the lowest level in 2023, indicating a faster contraction in purchasing activities in the month.

By size of enterprises, the PMI of 'large enterprises' rose to 50.3 in June from 50.0 in May. The PMI of 'medium enterprises' picked up to 48.9 in June from 47.6 in May. The PMI of 'small enterprises' dropped to 46.4 in June from 47.9 in May.

The output index increased to 50.3 in June from 49.6 in May. The output indices of 'large enterprises' and 'medium enterprises' were above the neutral level of 50, registering 52.7 and 50.2 respectively in June. Meanwhile, the output index of 'small enterprises' remained below 50, registering 45.7 in the month.

The new orders index edged up to 48.6 in June from 48.3 in May. The new orders index of 'large enterprises' stayed in the expansionary zone, registering 51.0 in June. Meanwhile, the new orders indices of 'medium enterprises' and 'small enterprises' stayed in the contractionary zone, registering 48.5 and 44.0 respectively in the month.

The new export orders index declined to 46.4 in June from 47.2 in May. The new export orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 47.9, 46.5 and 39.4 respectively in June.

The backlogs of orders index went down to 45.2 in June from 46.1 in May. The backlogs of orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the neutral level of 50, registering 47.0, 45.0 and 41.9 respectively in June.

The stocks of finished goods index fell to 46.1 in June from 48.9 in May. The stocks of finished goods indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were all in the contractionary zone, registering 46.3, 47.0 and 44.6 respectively in June.

The stocks of major inputs index dropped to 47.4 in June from 47.6 in May. The stocks of major inputs indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 47.2, 48.0 and 47.2 respectively in June.

The purchases of inputs index edged down to 48.9 in June from 49.0 in May. The purchases of inputs index of 'large enterprises' stayed in the expansionary zone, registering 51.5 in June. Meanwhile, the purchases of inputs indices of 'medium enterprises' and 'small enterprises' remained below 50, registering 48.4 and 44.5 respectively in the month.

The imports index came in at 47.0 in June, down from 48.6 in May. The imports indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the neutral level of 50, registering 48.1, 45.8 and 42.8 respectively in June.

The input prices index surged to 45.0 in June from 40.8 in May. The input prices indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 44.0, 45.2 and 46.7 in June.

The ex-factory prices index rose to 43.9 in June from 41.6 in May.¹ The ex-factory prices indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the neutral level of 50, registering 43.5, 44.6 and 43.9 respectively in June.

The employment index went down to 48.2 in June from 48.4 in May. The employment indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all stayed in the contractionary zone, registering 48.4, 47.9 and 48.2 respectively in June.

The suppliers' delivery time index came in at 50.4 in June, down from 50.5 in May. A reading above 50 implies faster delivery; below 50, slower delivery. The suppliers' delivery time indices of 'large enterprises', 'medium enterprises' and 'small enterprises' registered 50.3, 50.6 and 50.5 respectively in June.

The business expectations index fell to 53.4 in June from 54.1 in May.² The business expectations indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were 54.6, 53.1 and 51.4 respectively in June.

¹ The ex-factory prices index has been published since January 2017.

² Since January 2017, a new method of seasonal adjustment to the business expectations index has been adopted; and accordingly, the historical readings of the index have been revised.

CFLP

China Federation of Logistics & Purchasing (CFLP) is the logistics and purchasing industry association approved by the State Council. CFLP's mission is to push forward the development of the logistics industry and the procurement businesses of both government and enterprises, as well as the circulation of factors of production in China. The government authorizes the CFLP to produce industry statistics and set industry standards. CFLP is also China's representative in the Asian-Pacific Logistics Federation (APLF) and the International Federation of Purchasing and Supply Management (IFPSM).

NBS

The National Bureau of Statistics (NBS), an agency directly under the State Council in China, is in charge of the country's statistics. It is responsible for formulating statistical policies and establishing the national statistical system, drafting and enforcing the statistical laws and regulations, setting up and improving the national economic accounting system, conducting censuses, as well as making statistical analyses and forecasts of the macroeconomy, social development, scientific advancement, resources and environment.

China Manufacturing PMI

China Manufacturing Purchasing Managers' Index (PMI) provides an early indication each month of economic activities in the Chinese manufacturing sector. It is jointly published by China Federation of Logistics & Purchasing (CFLP) and the National Bureau of Statistics (NBS). Fung Business Intelligence is responsible for drafting and disseminating the English PMI report.

Every month questionnaires are sent to 3,000 manufacturing enterprises all over China. The data presented herein is compiled from the enterprises' responses about their purchasing activities and supply situations. CFLP makes no representation regarding the data collection procedures, nor does it disclose any data of individual enterprises. The PMI should be compared to other economic data sources when used in decision-making.

3,000 manufacturing enterprises in 31 industries from Eastern, Northeastern, Central and Western China are surveyed. The sampling of the enterprises involves the use of Probability Proportional to Size Sampling (PPS), which means the selection of enterprises surveyed is largely based on each industry's contribution to GDP, and the representation of each geographical region.

There are 13 sub-indicators in the survey: Output, New Orders, New Export Orders, Backlogs of Orders, Stocks of Finished Goods, Purchases of Inputs, Imports, Input Prices, Stocks of Major Inputs, Ex-factory Prices, Employment, Suppliers' Delivery Time and Business Expectations. An index reading above 50 indicates an overall positive change in a sub-indicator; below 50, an overall negative change.

The PMI is a composite index based on the seasonally adjusted indices for five of the sub-indicators with varying weights: New Orders—30%; Output—25%; Employment—20%; Suppliers' Delivery Time—15%; and Stocks of Major Inputs—10%. A PMI reading above 50 indicates an overall expansion in the manufacturing sector; below 50, an overall contraction.

Currently there are more than twenty countries and regions conducting the PMI survey and compilation, based on an internationally standardized methodology.
