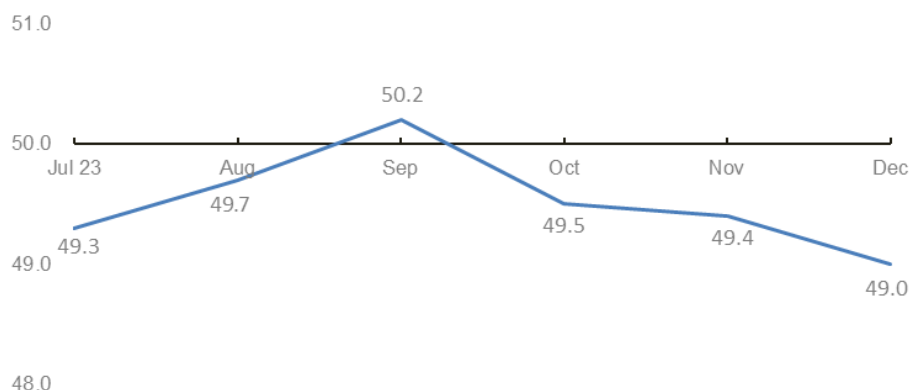


# PMI Report on China Manufacturing

## China’s manufacturing PMI falls to 49.0 in December, indicating a further contraction in the manufacturing sector

Nine of the 13 sub-indices were lower than their respective levels in the previous month. For example, the new orders index went down by 0.7 pts to 48.7 in December, pointing to a persistent contraction in market demand. The new export orders index declined by 0.5 pts to 45.8 in the month, indicating that new export orders have dropped at a faster pace recently. Against this backdrop, the growth in production activities has slowed: The output index decreased by 0.5 pts to 50.2 in December. Furthermore, the input prices index rose by 0.8 pts to 51.5 in December, while the ex-factory prices index fell by 0.5 pts to 47.7 in the month. Also noteworthy is that the business expectations index edged up by 0.1 pts to a 10-month high of 55.9 in December.

By size of enterprises, the PMI of 'large enterprises' dropped to 50.0 in December from 50.5 in November. The PMI of 'medium enterprises' inched down to 48.7 in December from 48.8 in November. The PMI of 'small enterprises' went down to 47.3 in December from 47.8 in November.

The output index declined to 50.2 in December from 50.7 in November. The output indices of 'large enterprises' and 'medium enterprises' remained above the neutral level of 50, registering 51.5 and 50.1 respectively in December. Meanwhile, the output index of 'small enterprises' remained below 50, registering 47.7 in the month.

The new orders index fell to 48.7 in December from 49.4 in November. The new orders index of 'large enterprises' stayed in the expansionary zone, registering 50.2 in December. Meanwhile, the new orders indices of 'medium enterprises' and 'small enterprises' stayed in the contractionary zone, registering 48.1 and 46.5 respectively in the month.

The new export orders index dropped to 45.8 in December from 46.3 in November. The new export orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 45.3, 46.3 and 46.9 respectively in December.

The backlogs of orders index edged up to 44.5 in December from 44.4 in November. The backlogs of orders indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the neutral level of 50, registering 46.3, 44.1 and 41.5 respectively in December.

The stocks of finished goods index declined to 47.8 in December from 48.2 in November. The stocks of finished goods indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all stayed in the contractionary zone, registering 49.1, 48.4 and 44.4 respectively in December.

The stocks of major inputs index went down to 47.7 in December from 48.0 in November. The stocks of major inputs indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the critical 50-mark, registering 49.0, 48.0 and 44.7 respectively in December.

The purchases of inputs index decreased to 49.0 in December from 49.6 in November. The purchases of inputs index of 'large enterprises' stayed in the expansionary zone, registering 50.9 in December. Meanwhile, the purchases of inputs indices of 'medium enterprises' and 'small enterprises' remained below 50, registering 48.6 and 45.6 respectively in the month.

The imports index came in at 46.4 in December, down from 47.3 in November. The imports indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the neutral level of 50, registering 47.0, 44.3 and 47.8 respectively in December.

The input prices index increased to 51.5 in December from 50.7 in November. The input prices indices of 'large enterprises' and 'medium enterprises' remained above the critical 50-mark, registering 52.7 and 50.9 respectively in December. Meanwhile, the input prices index of 'small enterprises' remained below 50, registering 49.8 in the month.

The ex-factory prices index decreased to 47.7 in December from 48.2 in November.<sup>1</sup> The ex-factory prices indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all remained below the neutral level of 50, registering 49.0, 46.0 and 47.2 respectively in December.

The employment index edged down to 47.9 in December from 48.1 in November. The employment indices of 'large enterprises', 'medium enterprises' and 'small enterprises' all stayed in the contractionary zone, registering 48.1, 47.7 and 47.7 respectively in December.

The suppliers' delivery time index came in at 50.3 in December, the same as in November. A reading above 50 implies faster delivery; below 50, slower delivery. The suppliers' delivery time indices of 'large enterprises', 'medium enterprises' and 'small enterprises' registered 49.8, 50.8 and 50.6 respectively in December.

The business expectations index climbed to 55.9 in December from 55.8 in November.<sup>2</sup> The business expectations indices of 'large enterprises', 'medium enterprises' and 'small enterprises' were 57.9, 56.2 and 51.4 respectively in December.

## CFLP

### 中國物流與採購聯合會

China Federation of Logistics & Purchasing (CFLP) is the logistics and purchasing industry association approved by the State Council. CFLP's mission is to push forward the development of the logistics industry and the procurement businesses of both government and enterprises, as well as the circulation of factors of production in China. The government authorizes the CFLP to produce industry statistics and set industry standards. CFLP is also China's representative in the Asian-Pacific Logistics Federation (APLF) and the International Federation of Purchasing and Supply Management (IFPSM).

## NBS

### 國家統計局

The National Bureau of Statistics (NBS), an agency directly under the State Council in China, is in charge of the country's statistics. It is responsible for formulating statistical policies and establishing the national statistical system, drafting and enforcing the statistical laws and regulations, setting up and improving the national economic accounting system, conducting censuses, as well as making statistical analyses and forecasts of the macroeconomy, social development, scientific advancement, resources and environment.

## China Manufacturing PMI

### 中國製造業採購經理指數

China Manufacturing Purchasing Managers' Index (PMI) provides an early indication each month of economic activities in the Chinese manufacturing sector. It is jointly published by China Federation of Logistics & Purchasing (CFLP) and the National Bureau of Statistics (NBS). Fung Business Intelligence is responsible for drafting and disseminating the English PMI report.

Every month questionnaires are sent to 3,000 manufacturing enterprises all over China. The data presented herein is compiled from the enterprises' responses about their purchasing activities and supply situations. CFLP makes no representation regarding the data collection procedures, nor does it disclose any data of individual enterprises. The PMI should be compared to other economic data sources when used in decision-making.

3,000 manufacturing enterprises in 31 industries from Eastern, Northeastern, Central and Western China are surveyed. The sampling of the enterprises involves the use of Probability Proportional to Size Sampling (PPS), which means the selection of enterprises surveyed is largely based on each industry's contribution to GDP, and the representation of each geographical region.

There are 13 sub-indicators in the survey: Output, New Orders, New Export Orders, Backlogs of Orders, Stocks of Finished Goods, Purchases of Inputs, Imports, Input Prices, Stocks of Major Inputs, Ex-factory Prices, Employment, Suppliers' Delivery Time and Business Expectations. An index reading above 50 indicates an overall positive change in a sub-indicator; below 50, an overall negative change.

The PMI is a composite index based on the seasonally adjusted indices for five of the sub-indicators with varying weights: New Orders—30%; Output—25%; Employment—20%; Suppliers' Delivery Time—15%; and Stocks of Major Inputs—10%. A PMI reading above 50 indicates an overall expansion in the manufacturing sector; below 50, an overall contraction.

Currently there are more than twenty countries and regions conducting the PMI survey and compilation, based on an internationally standardized methodology.
